

COMMUNITY MANAGER POSITION IN SOCLIMPACT PROJECT (“DOWNSCALING CLIMATE IMPACTS AND DECARBONISATION PATHWAYS IN EU ISLANDS, AND ENHANCING SOCIOECONOMIC AND NON-MARKET EVALUATION OF CLIMATE CHANGE FOR EUROPE, FOR 2050 AND BEYOND”), FUNDED BY THE HORIZON 2020 PROGRAM (SC5-06-2016-2017, GRANT AGREEMENT Nº 776661) FOR THE PERIOD 2017-2020.

The University of Las Palmas de Gran Canaria (ULPGC), Spain wishes to appoint 1 Community Manager contract to work in the EU Project SOCLIMPACT during 19 months.

The SOCLIMPACT project (“Downscaling Climate Impacts and Decarbonisation Pathways In EU Islands, And Enhancing Socioeconomic and Non-Market Evaluation Of Climate Change For Europe, For 2050 And Beyond”), funded by the Horizon 2020, aims at modelling and assessing downscaled CC impacts and low carbon transition pathways in European islands and archipelagos for 2050 - 2100, complementing current available projections for Europe, and nourishing actual economic models with non-market assessment.

The University will recruit the best candidate following the recommendations of the European Charter for Researchers and the Code of Conduct for the Recruitment of Researchers. The job offer will be published through a wide range of portals. The evaluation of candidates and their selection criteria will be aligned with the equal opportunities policies of the ULPGC. Selection and hiring procedures will follow transparent mechanisms attending national and regional legislation.

The selection committee will be composed by Mr. Antonio Marcelino Santana González (General Manager of Fundación Canaria Parque Científico y Tecnológico at the ULPGC), Ms. Almudena Suárez (who will act as secretary of the commission), Prof. Carmelo León González (SOCLIMPACT coordinator at ULPGC, who will act as President of the Commission) and Mr. Sergio Moreno Gil (researcher of SOCLIMPACT project).

PREREQUISITES

The candidates must comply the following conditions:

1. Nationality:
 - a. Spanish nationality or that of one of the other member states of the European Union.
 - b. Whatever his nationality, spouses of Spaniards and nationals of other Member States of the European Union.
 - c. People included into International Agreements concluded by the European Union and ratified by Spain, related to free movement of workers.
 - d. Foreign candidates not included in paragraphs above, legally resident in Spain.



2. Age: Be over eighteen.
3. Degrees: hold a university degree. Applicants with qualifications obtained abroad, must prove that they are in possession of the corresponding validation or the credential that accredit, where appropriate, the homologation.
4. Language: Demonstrate a good level of English (min. level B2).
5. Experience: experience in consultancy and technical assistance in communication and marketing, digital environment, design, communication plans.

WORKING CONDITIONS

This temporary contract is for specified work and services for the execution of SOCLIMPACT project in the Foundation Canary Scientific and Technology Park of the University of Las Palmas de Gran Canaria.

More specifically the tasks to be performed will be:

- Daily communication and coordination with partners and members of SOCLIMPACT consortium, as well as other stakeholders.
- Support the communication and dissemination plan of the project and the implementation of a strategy for the dissemination of results to different audiences.
- Update the website of the project and management of social networks, press documents, and newsletters.
- Support the tasks of WP8 related to reports and deliverables delivery to the EC.
- Preparation of the communication materials and web positioning.
- Support on the organisation of meetings, events within the project.
- Internal coordination with members of TIDES institute.

The contract will conclude in case of funding shortfall. The position is suitable for a part-time employment. Gross salary: 1.000,00 €/month.

The start of the contract is estimated by May 2019 for a period of 19 months. The person hired will work for the SOCLIMPACT Project at the Institute of Tourism and Sustainable Economic Development (TIDES), in the University of Las Palmas de Gran Canaria, Canary Islands, Spain.

EVALUATION

The following items and scores will be taken into account in order to evaluate the CV submitted:

1.- Qualifications (Max. 1,5 points):

- Communication, Journalism, Design and Marketing (0,50 points/qualification)
- Project Management and/or International Relations (0,25 points/qualification)

2.- Working experience (Max. 5 points):

- Consultancy and technical assistance: communication in projects of social and environment relevance funded by national or international calls (0.5 points/project; Max. 2 points).
- Consultancy and technical assistance: communication plans for enterprises, organisation of events, brand design, web positioning (0.5 points/service; Max. 2 points).

3.- Further training (Max. 2 points):

- Project management courses, audiovisual communication, web design (Wix, Linux), graphic design, copywriting, tableau software, events management (0.25 points/course min. 20 hours).
- Office Package, Adobe, data bases courses (0.25 points/course min. 20 hours).



4.- Language skills (Max. 1,5 points):

- English Level higher than B2: 1 point.
- French Level higher than A1: 0,5 points.

5.- Interview (Max. 10 points)

The evaluation commission has the right to propose no candidate to this contract if it is found that no one fulfills the necessary experience to participate in this project.
