

**PROJECT SUPPORT POSITION (TCP3) IN SOCLIMPACT PROJECT (“DOWNSCALING CLIMATE IMPACTS AND DECARBONISATION PATHWAYS IN EU ISLANDS, AND ENHANCING SOCIOECONOMIC AND NON-MARKET EVALUATION OF CLIMATE CHANGE FOR EUROPE, FOR 2050 AND BEYOND”), FUNDED BY THE HORIZON 2020 PROGRAM (SC5-06-2016-2017, GRANT AGREEMENT Nº 776661) FOR THE PERIOD 2017-2020.**

The University of Las Palmas de Gran Canaria (ULPGC), Spain wishes to appoint 1 Project Support contract to work in the EU Project SOCLIMPACT during 30 months.

The SOCLIMPACT project (“Downscaling Climate Impacts and Decarbonisation Pathways In EU Islands, And Enhancing Socioeconomic and Non-Market Evaluation Of Climate Change For Europe, For 2050 And Beyond”), funded by the Horizon 2020, aims at modelling and assessing downscaled CC impacts and low carbon transition pathways in European islands and archipelagos for 2050 - 2100, complementing current available projections for Europe, and nourishing actual economic models with non-market assessment.

The University will recruit the best candidate following the recommendations of the European Charter for Researchers and the Code of Conduct for the Recruitment of Researchers. The job offer will be published through a wide range of portals. The evaluation of candidates and their selection criteria will be aligned with the equal opportunities policies of the ULPGC. Selection and hiring procedures will follow transparent mechanisms attending national and regional legislation.

The selection committee will be composed by Mr. Antonio Marcelino Santana González (General Manager of Fundación Canaria Parque Científico y Tecnológico at the ULPGC), Ms. Almudena Suárez (who will act as secretary of the commission), Prof. Carmelo León González (SOCLIMPACT coordinator at ULPGC, who will act as President of the Commission) and Mr. Matías González Hernández (researcher of SOCLIMPACT project).

## PREREQUISITES

The candidates must comply the following conditions:

1. Nationality:
  - a. Spanish nationality or that of one of the other member states of the European Union.
  - b. Whatever his nationality, spouses of Spaniards and nationals of other Member States of the European Union.
  - c. People included into International Agreements concluded by the European Union and ratified by Spain, related to free movement of workers.
  - d. Foreign candidates not included in paragraphs above, legally resident in Spain.



2. Age: Be over eighteen.
3. Degrees: possession of a Bachelor's Degree. Other degrees and/or doctoral studies will be positively evaluated.
4. Language: Demonstrate a good level of English (min. level B2).
5. Research experience: minimum 2 years experience in the following areas: Environmental Economic Valuation; Socioeconomic impact assessment; Scientific coordination of publications and international events or seminars.
6. Professional experience: minimum 2 years experience in EU Projects.

## **WORKING CONDITIONS**

This temporary contract is for specified work and services for the execution of SOCLIMPACT project in the Foundation Canary Scientific and Technology Park of the University of Las Palmas de Gran Canaria.

More specifically the tasks to be performed will be:

- Coordination of the scientific activities of SOCLIMPACT project.
- Responsible of ensuring compliance of the workplan of the project.
- Communication and coordination with the workpackage leaders and TIDES research team to improve the efficiency of the results and quality outcomes of the project.
- Support the preparation of the technical reports and deliverables of the project to the EC.
- Technical coordination of the research lead by the TIDES institute in the areas of social valuation, data mining and the socio-economic modelling proposed in the project.
- Coordination of new project initiatives to be submitted to national and international (European) calls for projects, to secure a long-term financial support of the Tides research line. Eventually participation in seminars and congress presentations, as well as scientific papers writing.

The candidate is expected to join a Ph.D. program of the ULPGC (if he / she is not), and to carry out his / her thesis for the duration of the contract.

The contract will conclude in case of funding shortfall. The position is suitable for a part-time employment. Gross salary: 1.518,38 €/month.

The start of the contract is estimated by July 1<sup>st</sup> 2018, and the duration is estimated in 30 months. The person hired will work for the SOCLIMPACT Project at the Institute of Tourism and Sustainable Economic Development (TIDES), in the University of Las Palmas de Gran Canaria, Canary Islands, Spain.

## EVALUATION

The following items and scores will be taken into account in order to evaluate the CV submitted:

### 1.- Research experience (Max. 13 points):

- High-impact scientific papers published in the following areas: economic modelling, environment and climate change (0,5 points for each article; Max. 4 points).
- High-impact scientific papers published in the following areas: theoretical and applied general equilibrium models, and evaluation of socio-economic impacts (0,5 points for each article; Max. 4 points).
- Author/Edition of books or book chapters in the following areas: marine-maritime environment, climate and environment (0,2 points per publication; Max. 3 points).
- Participation in international Congresses / Seminars (0,2 points per congress; Max. 1 point).
- Other degrees, doctoral studies, prizes and recognition of research in the following areas: Tourism and/or Economy (0,25 points for recognition; Max. 1 point).

### 2.- Professional experience (Max. 6 points):

- Participation as researcher in EU Research and Innovation Projects funded by H2020, Interreg, Erasmus+, Life, Cosme, etc.. (0,2 points per project; Max. 2 points).



- Participation as researcher in Research and Innovation Projects (national and international level) related to climate change, environment, technology and tourism (0,25 points per each International project and 0,10 points per each National project; Max. 2 points).
- Research stages outside their native country (0,25 points per year; Max. 2 points).

### **3.- Language skills (Max. 1 point):**

- English Level higher than B2: 1,0 point.
